Participation is open to all residents within and around the immediate city limits of St. Matthews.

Contest is for exterior decorations only, including decorations in windows that are visible from the exterior.

Judging will be done from outside the residence only.

Entering this contest gives consent for photos of the exterior of the residence to be featured in local media, Chamber social media outlets, Chamber and City websites, and/or published in the Chamber and City newsletters.

Contestants will submit photos or 20 to 30 second video clips of their displays. These will be used by judges to determine their winners and will also be posted on social media and other outlets to encourage members of the community to drive by their home to see the decorations.

Judging criteria will include unique design, creative use of lights and decorations, historic nostalgia where appropriate, and overall presentation.

Types of acceptable lighting include, but are not limited to mini string lights, rope light, neon signs, LED tape light, flood lights, and patio lights. Unacceptable lighting includes vulgar or inappropriate displays, any and all fire or pyro technics, and/or any display that endangers surrounding homes.

Judging will be done between Dec. 5th and Dec. 8th with winners announced on December 8th.

Participants should ensure that all lights and decorations are in place and activated for the judging periods listed above.

All participants will be considered for the following categories: Best in Show, Clark Griswold (most lights), and People's Choice.
